Patents

Patents give inventors the strategic advantage of managing the production, use and sale of their patented products or processes in the European Union. This exclusivity can provide a competitive edge and help expand the market by reassuring and attracting customers, investors and licensing partners interested in new and innovative technologies. Patent protection can also enhance credibility, making it easier to enter the EU market and establish new, and extend existing partnerships. The European Patent Office grants a European patent which can be validated in an even greater economic area covering 45 European, Asian and African countries.





In addition, it is now possible to request a Unitary Patent ("European patent with unitary effect"), which provides unified patent protection in 18 EU countries

The annuity fees for a Unitary Patent are significantly reduced compared to the annuity fees for traditional patents validated in 5 countries or more.

Decisions concerning infringement and nullity of a European or Unitary Patent in 18 EU countries can now be obtained via a single action filed with the newly established Unified Patent Court. This makes a European patent even more valuable and the Unified Patent Court is becoming one of the most relevant litigation hubs in the world.

Supplementary Protection Certificate (SPC)

A patent typically gives its owner exclusive rights to an invention for 20 years from filing. However, in the case of inventions relating to medicinal or plant protection products, the approval procedure required for placing the product on the market often takes a significant portion of this twenty-year protection period. To support research into new medicinal and plant protection products, a "compensation scheme" has been established within the European Union via Supplementary Protection Certificates (SPCs).

These SPCs may extend protection beyond the initial patent validity period by up to five years for medicinal or plant protection products. Additionally, an extra six months may be granted if a medicinal product's approval includes paediatric studies and is authorized in all EU countries.
